OUTGOING PRESIDENT REFLECTIONS

The success of LCCWA is dependent on our board, volunteers, supporting members and sponsors. Reflecting on my term as president (2012 and 2013) I am proud of our continued education, promotion and advocacy efforts on behalf of agriculture.

We were able to grant three \$1,000 scholarships each year, baked and sold zillions of pies and turnovers for the Pear Festival, completed years three and four of AgVenture, advocated legislatively at the local and state level and attended a few CWA Statewide meetings (SWM). LCCWA board members Toni Scully and Terry Dereniuk, along with Linda Hedstrom and Cathy Koehler attended January's 39th Annual Convention and State Wide Meeting held January 10-12 in Petaluma. This group of gals, who oversaw the hospitality booth, gave attendees a literal taste of Lake County by offering pear and persimmon treats with an AgVenture Powerpoint presentation playing in the background to promote interest, reports board member Rebecca Southwick.

Other highlights of the convention included tours of the Petaluma Creamery, Dairy Dell, and Lagunitas Brewing Company.

Assemblyman Mark Levine and Sonoma County Second District Supervisor David Rabbitt were on board to welcome attendees.

Newly installed chapter officers attended workshops designed for them, and "A Legislative boot camp was also held to prepare for CWA's yearly visit to Sacramento to communicate the agricultural industry's concern to elected officials", states Southwick.

Nearly 100 members from 17 of California's 20 chapters in good standing attended this convention, and we are highly pleased with our representation there.

LAKE COUNTY FARM BUREAU NEWS

Lake County Farm Bureau has undertaken two new projects. The first concerns Lake County's "Right to Farm" ordinance. A few Farm Bureau directors and Executive Director Claudia met with representatives of the Planning Commission, the Assessor's Office, and the Lake County Board of Realtors to discuss the realtors' desire to eliminate the burden of recording a signed "Right to Farm" document with every local sale. After much discussion, it was generally agreed that the best solution is to have an abbreviated version of the ordinance appear on all annual tax bills (either printed on the return envelope or as an insert with the bill) and also on all supplemental tax bills. Realtors would still require that buyers sign the ordinance, but they would not have to record the document. To further spread awareness, LCFB will develop "Right to Farm" posters for display.

The second project underway is the creation of a Political Advisory and Education Committee in conjunction with the Lake County Sierra Club and Lake County CWA. This committee will interview candidates for seats on the Lake County Board of Supervisors and also candidates for State Assembly or Senate. The committee could also hear proponents and opponents of legislative issues of particular interest to agriculturists or environmentalists. By joining with Sierra Club for these interviews, we hope to better determine the true positions of candidates. We already have our first round of interviews set up for the District 2 and 3 Supervisorial candidates. *-Diane Henderson.*



SCHOLARSHIP DEADLINE APPROACHING

Once again, LCCWA will be offering scholarships to graduating high school seniors and college or vocational students (regardless of gender) who will be enrolled in a two or four year program in a field related to agriculture. Scholarships are offered up to an amount of \$1,000, and will be released in two installments. Three \$1,000 scholarships were awarded last year.

Students must:

- Be a resident of Lake County
 - Have a grade point average of 3.0 or greater
 - Fill out the requisite scholarship application packet, which acknowledges pursuit of a career related to agriculture
 - Be willing to participate in an interview with the LCCWA Scholarship Committee if requested

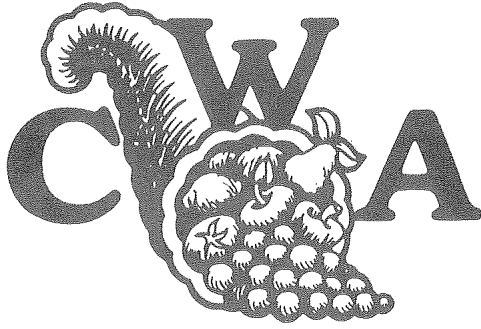
