SCHOLARSHIP UPDATESSubmitted by Sausha Racine

We are pleased to begin accepting scholarship applications from graduating high school seniors and college or vocational students now through April 15, 2022 for the 2022/2023 academic year. Scholarships may range between \$500 and \$2500 per award. Applicants must be pursuing a degree that is related to agriculture and planning to attend a two- or four-year program as a full-time student.

Since 2013 our chapter has awarded over \$41,500 in scholarships to local students including \$4,500 awarded in 2021. Lake County graduating high school seniors and college or vocational students who have a grade point average of 3.0 or above are eligible to apply. Application materials must be received by CWA on or before April 15, 2022. The application and criteria can be found in this newsletter! FARM BUREAU HAPPENINGSSubmitted by Executive Director, Brenna Sullivan

The Lake County Farm Bureau is planning an Annual Meeting at the end of June! Stay tuned for a save-the-date reminder and invitation! We thank everybody who has donated to our scholarship program over the past two years of the pandemic! We are very much looking forward to seeing everybody for an in-person Annual Meeting this summer.

Lake County Farm Bureau scholarship applications are now available at the Farm Bureau website! Visit www.lakecofb.com to download the application. The Farm Bureau scholarships are available to Lake County students who are attending or plan to attend college, university or a trade school in pursuit of an agricultural degree. Deadline for submittal is April 8.

The Big Valley Groundwater Sustainability Plan (GSP) was submitted to California Department of Water Resources on January 31, 2022. The GSP will now enter a 75 day comment period after which California DWR will either accept the Plan or require modifications. The Advisory Committee will continue meeting to advise on fee structures and plan implementation. The GSP will be available for viewing on the Lake County Water Resources website following official submittal. If you are a member of the Irrigated Lands Program, make sure to update your information into www.subwatershed.com by the end of February! This will ensure compliance with the program. Re: CWA Annual Scholarships

The Lake County Chapter of California Women for Agriculture is offering scholarships from \$500 to \$2500 to graduating high school seniors and college or vocational students (regardless of gender) whose **educational emphasis is related to agriculture** and who will be attending a two- or four-year program as a full-time student. Scholarship recipients will receive their scholarship at the beginning of the first semester conditioned on proof of full-time enrollment. Selected students will be encouraged to attend a CWA Chapter meeting during the coming year to describe course of study and how the scholarship has assisted in the pursuit of educational and career goals.

Students must:

- Be a resident of Lake County
- Have a grade point average of 3.0 or greater
- Fill out the requisite scholarship application packet, which acknowledges a pursuit of a career related to agriculture. Applications which do not clearly convey the applicant's pursuit of a career as it relates to agriculture will not be considered.
- Be willing to participate in an interview with the CWA Scholarship Committee if requested.

The application packet must include:

- The CWA signed application form
- A letter of recommendation
- A current or most recent transcript

The application form is enclosed and must be **received** by CWA with all other required application material on or before **April 15**, **2022**. Applications without all required material will not be considered.
